





# TERMS OF REFERENCE

Consultancy: Elaboration of an organizational diagnosis for four community and indigenous peoples' organizations and a training plan for the technical, administrative and financial strengthening of AMPB member organizations.

Project: "Enabling territorial investment in organizations of Indigenous Peoples and local communities in Mesoamerica".

#### 1- INTRODUCTION

The Mesoamerican Alliance of Peoples and Forests (AMPB) is a space for coordination and exchange with territorial authorities that manage and influence the main forest masses of Mesoamerica. Indigenous Peoples and community forestry organizations strengthen dialogue processes focused on community management of natural resources, advocacy with governments and international cooperation so that biodiversity conservation and climate balance strategies appropriately integrate the rights and benefits to Indigenous Peoples and forest communities. Indigenous Peoples and local communities in Mesoamerica for generations have demonstrated important contributions to maintaining the conservation of the most important natural environments in the region, making major contributions to climate stability in the hemisphere.

The AMPB is a platform created by the indigenous authorities and forest communities of Mesoamerica, who together inhabit and care for tropical forests from Mexico to Panama. And through the Mesoamerican Territorial Fund (FTM) is implementing the project "Enabling territorial investment in indigenous peoples' organizations and local communities of Mesoamerica", especially in capacity building in local member organizations of AMPB in administrative and financial issues and influence greater climate investment for territories and communities in order to strengthen the tenure rights of indigenous peoples and communities as a strategic line.

The <u>Mesoamerican Territorial Fund</u> (FTM) is a direct financial investment mechanism to support indigenous peoples' organizations and local communities in strengthening livelihoods, consolidating the rights of Indigenous Peoples, implementing climate change adaptation and mitigation activities, biodiversity conservation, and supporting socially and environmentally sustainable economic enterprises with an inclusive and equitable approach. The FTM generally supports the achievement of the Millennium Development Goals.





Sustainable Development Goals (SDGs) and the Nationally Determined Contributions (NDCs) at the territorial level to which countries have committed at the global level to reverse climate change and social inequalities.

# The FTM has the following focuses:

- Aimed at local investment for economic, environmental and food self-sustainability.
- Rights-based for empowerment and local development through recognition of the rights of Indigenous Peoples and local organizations over forests and territories, as well as respect for free, prior and informed consent.
- Based on the principles of equality, inclusion, full and effective participation of Indigenous Peoples and local organizations to support initiatives that respond to their needs.
- Based on territorial alliances to generate greater synergies within the territory and greater positive impacts.
- Based on a monitoring and evaluation system that allows the follow-up of processes for efficient and transparent investment decision-making.
- Opening of open calls for small and medium-sized grants in order to be able to receive applications from any territory in the Mesoamerican region.

The management process of organizations is represented in the control and monitoring of operations to comply with established rules, the efficient management of resources and processes, project management and leveraging resources for their development. The lack of systematization, records and financial monitoring are critical points for them. Experience shows that the incorporation of partners in the supervision of technical, administrative and financial activities facilitates the growth of the organizations and constitutes a mechanism for generating trust within the social base.

To carry out the implementation of this consultancy, whose expected result is to strengthen financial and administrative aspects in particular four member organizations of AMPB with planning instruments, their administrative-financial management and accountability, it is required the hiring of a consultant to prepare a situational diagnosis on the administrative and financial practices of four partner organizations that will identify strengths, weaknesses and contribute to continuous improvement and decision making.

#### 2. OBJECTIVE OF THE CONSULTANCY

Elaborate an organizational diagnosis with emphasis on the organizational, administrative and financial areas for four AMPB member organizations to generate concrete recommendations for strengthening their management and the elaboration of a training plan for organizational, project management, administrative and financial strengthening of AMPB member organizations.

#### 3. ACTIVITIES TO BE PERFORMED

- Participate in a meeting with FTM's financial management to discuss the work plan, schedule and coordination of actions to be developed.
- Develop a training plan and methodology proposal for project management, administration and finance.
- Review the internal controls implemented by the organizations in order to identify areas for improvement.
- Conduct interviews with key personnel in the organization who handle administrative and financial resources to learn about procedures.
- Use the SWOT methodology and design a rating scale to categorize organizations and identify key points of change in operational management.
- Review previous audits carried out in the last two years for each organization, if any.
- Meeting with key personnel of the organization for the return of the diagnostic results.
- Prepare diagnostic report and recommendations and incorporate final observations.
